Students must follow following steps carefully while filling scholarship form

- 1) Login on mahadbt (with your previous id & password)
- 2) In first page where your adhar no. is mentioned click on update button .(update as per adhar)
- 3) Students who belongs to SC/ST/OBC/SBC/VJNT don't make any changes in INCOME last year (24-25) income allowed till pass out.(income limit for scholarship 2.50 lakh) (for freeship non cremelayer is compulsory valid till March 2026)
 - (Student who take admission from above category in Against cap vacancy & their income limit is 2.50 lakh they can apply for mahadbt scholarship)
- 4) Students who belongs to SEBC they must upload income certificate for the year 24-25 & non cremelayer (valid till March 26) in one file (both documents must upload)
- 5) Students who belong to EWS & EBC they must upload income certificate for the year 24-25 SEBC, EWS, EBC against cap admitted was not eligible for any scholarship.
- 6) Check students bank details make required changes (adhar must link with bank account) students must submit bank seeding form at the time of submission of hard copy.
- 7) Make required changes in personal address, and parents details.


